NEWS FROM THE BOTTOM

What a tumultuous and unforgettable year this has been! Arab Mountain, the tower and Summit Museum

bore silent witness to the COVID pandemic that even impacted our northern NY wilderness areas. In their unending quest to stay healthy many folks continued journeying north to the Adirondacks for exercise, serenity, and an escape from the crowds and turmoil associated with congested city life.

The foresight of our FOMA Board of Directors correctly anticipated large crowds recreating on Arab Mountain and surrounding environs and we made the decision to not staff the mountain top and trail due to greatly increased day to day virus transmission risks. Crowds were large and many climbers avoided touching things such as trailhead sign-in registers so we have no accurate count of the numbers of visitors except to guess that it was very large judging by the overflowing numbers of cars observed daily in the parking lot. Personal observations by Board Members and patrons described large crowds congregating at the summit, many ignoring NYSDEC rules to not crowd into the cab. If I had been assigned to the summit I would have been exposed to potential infection by someone among the hundreds of visitors daily throughout the summer by people visiting from those downstate centers of infection, hence our decision to eliminate staffing was a sound one.

In light of the outbreak NYSDEC initially closed all fire towers in our State but had no personnel to enforce the decision, hence many people routinely violated the prohibition. As we moved into summer NYSDEC relaxed the rules and allowed access to the tower cab with the stipulation that occupancy be limited to one climbing party at a time. FOMA workers did manage to dramatically improve sections of the trail, refresh the exterior of the tower with a gleaming new paint job, and install the long awaited tower cab windows so our mountain has shown dramatic improvement despite the pandemic.

Repeated observation by climbers and Board Members have shown minimal vandalism and litter on the trail, tower, outhouse, and summit areas, and that our patrons generally behaved in an environmentally sound manner. Kudos to all.

In summary I plan on getting an early vaccine in 2021 and resuming my duties right around Mother's Day. I hope to see many of you folks again.

Pandemic Closing and Reopening

In consideration of the COVID pandemic, DEC closed the tower and observer's cabin on 27 March. As of 26 June the DEC reopened the tower subject to conditions – only one party of limited size at a time followed by hand sanitizing. Aaron Graves, DEC Forester, went up the mountain on 2 July and posted those tower use conditions. In no case was climbing the mountain ever restricted. FOMA made the decision early in 2020 to not employ a summit steward this year.

Trail Reroute and Improvements

Sheila Young reported via Aaron Graves that in June 2020 'Tahawas Trails' had done an excellent job rerouting a small portion of the trail as well as making additional trail improvements. I am fully impressed. Attached, in Word format, is my commentary and some photos. The Tahawas Trail crew didn't just construct a new trail - although that would have been enough - they also made 48 existing water bars deeper and longer, and added 8 new runoff trenches without rock down slope walls.



DEC arranged for the Student Conservation Association (SCA) Adirondack Corp crew to paint the Mount Arab fire tower. DEC did not have money for supplies and equipment so FOMA purchased the special 'Rust Grip' paint required (\$1263.30) and painting supplies (\$164). The SCA crew began on Monday 31 August, and working 10 hour days completed the job on 3 September.

Tower Windows – Completed

FOMA began work on installing the new aluminum tower windows in early September (while the paint crew was still working). This volunteer work was performed by Dick Bentley, Larry Lee, and Herman Vandenburgh, all on the FOMA board. Dick Bentley and Larry Lee finally completed the job on 4 October.

Plans for 2021

The tower needs a bit of work on the roof which will include a metal patch and then the entire roof needs a paint job. Following this FOMA will install the refurbished map table back into the tower cab. Hopefully we shall also be able to address a re-furbishing of the 4 horizon displays above the windows in the tower.
